## **RoHS Statement**

Microtrax Designs Ltd is pleased to confirm that, where appropriate, parts ordered into the business will be RoHS compliant, though we will also aim to support our clients who for a variety of reasons require non-ROHS builds because their products fall outside of the scope of the Directive. In addition to this, and where necessary we shall ensure that the necessary production controls necessary to ensure that RoHS and non-RoHS builds are clearly identified, processed and segregated accordingly.

The RoHS directive restricts the use of certain substances that are hazardous to health:

Lead, Cadmium, Mercury, Hexavalent Chromium Polybrominated Biphenyls (PBB), Polybrominated Diphenyl Ethers (PBDE) Bis(2-ethylhexyl) Phthalate (DEHP), Butyl Benzyl Phthalate (BBP) Dibutyl Phthalate (DBP), Diisobutyl Phthalate (DIBP)

## **REACH Statement**

As a supplier of assembled electronic 'articles' to our customers specifications and as a downstream user of chemical substances used in the manufacturing processes used by our suppliers, then we have an understanding of the requirements of the REACH Directive.

With the exception of products that are specified by the customer as being non-RoHS (containing lead), we do not knowingly export any articles that contain Substances of Very High Concern (SVHC's) that are on the Candidate List and with a concentration greater than 0.1% w/w. We maintain regular contact with or suppliers to avoid the unintentional use of SVHC materials on the REACH Candidate List.

We undertake to keep ourselves and partners informed of REACH and the ECHA Candidate List, as amended, and take the necessary steps to ensure that these substances are not included in the production of electronic 'articles' supplied.

When we are aware that substances on the Candidate List are present, we undertake to ensure they are in concentrations not greater than 0.1% w/w. All declarations are made in good faith based on the information supplied by manufacturers and suppliers to Microtrax Designs Ltd.

## **Conflict Materials**

As a supplier of Printed Circuit Board and Printed Circuit Assemblies, Microtrax Designs Ltd, are aware of our obligations with regards to the laws and regulations regarding Conflict Materials, specifically the Dodd-Frank Wall Street Reform and Consumer Protection Act Section 1502.

Microtrax Designs Ltd does not directly source or process Conflict Materials such as Tin, Tantalum, Tungsten, or Gold but these minerals are contained in some of the parts procured for the manufacture

of printed circuits and printed circuit assemblies that we procure to the specification made by our customers.

As part of our reasonable due diligence, Microtrax Designs Ltd has contacted the suppliers within our supply chain to verify their continued compliance with the regulations. Based on information received we can declare that our products do supply nor contain Conflict Materials from the Conflict Region.
